You replied that I should not do so. 2. Herewith letter of yesterday's date from Bill Van Straubenzee, together with a copy of a letter which was sent to his Chairman by Lord Salisbury, on behalf of the Anglo-Rhodesian Society. I also attach the reply which, subject to your approval, 3. I have in mind to send Bill. I think that what disturbed Bill was the paragraph numbered 4 of Lord Salisbury's letter. As you know, I hope that the Government will not ask Parliament to renew sanctions next month. However, if you decide that Parliament should be asked to renew sanctions, I will support the Government, and since the Anglo-Rhodesian Society will oppose the renewal of sanctions, I will, at that stage, retire from the Council, unless you think that I ought to do so now.

Dear Mr. Chairman,

The outcome of the Zimbabwe Rhodesia Conference may still not be clear when the Conservative Party Conference comes to debate Zimbabwe Rhodesia.

Many of us, however, consider that the following points can already be made with some certainty:-

- 1. Lord Home who devised five of the six principles and Sir Harold Wilson who devised the sixth have both declared that the present Rhodesian constitution conforms with the six principles which successive British Governments have sought to secure.
- 2. Lord Boyd's commission appointed by Mrs. Thatcher found that the Zimbabwe Rhodesian general election held in April was free and fair. So did most other observers.
- 3. Bishop Muzorewa's delegation to the Lancaster House Conference has now gone further and accepted in principle the additional changes in the Zimbabwe Rhodesian constitution required by H.M.G. as a result of the Lusaka Commonwealth Conference.
- 4. In these circumstances it seems to us unthinkable that the Conservative leadership which recommended abstention on the sanctions vote last November before the Rhodesian elections or Bishop Muzorewa's latest concessions to the British viewpoint could conceivably call for a renewal of sanctions this Autumn.
- 5. Furthermore, the maintainance of law and order, the production of sufficient food and the revival of the Zimbabwe Rhodesian economy will require the wholehearted co-operation of the white community.

Whatever your personal view on this issue, I feel sure you will accept that it is one of very great importance both internationally and to the people of our country. If you agree with the points I have made, may I suggest that your Association's delegation should give careful consideration to the opinions expressed in the debate and at the end make known their views in the usual way.
